

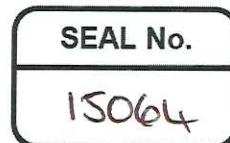
**TOWN POLICE CLAUSES ACT 1847**  
**Section 21 (as amended by the Criminal Justice Act 1967**  
**Schedule 3 and the Criminal Justices Act 1982**  
**Sections 39 and 46 and Schedule 3)**

The Parish of Eckington Temporary Street Closure Order (No 19) 2024

WHEREAS North East Derbyshire District Council being the local authority for the Parish of Eckington having been informed by Police of an anticipated or likely obstruction of streets within the Parish of Eckington is satisfied that all traffic and pedestrians should be prohibited and prevented from using roads or streets on the dates set out below in order to prevent an obstruction or obstructions occurring.

- 1 NOW THEREFORE North East Derbyshire District Council in exercise of the above and all other powers conferred on it by statute in this respect hereby makes the following Order :-
  - (a) No person shall on Friday 6<sup>th</sup> December 2024 cause or permit any vehicles to pass along Market Street between its junctions with Gosber Street and Southgate and part of Southgate to its junction with Station Road in the Parish of Eckington between the hours of 8:00am (08:00 hours) and 9:00pm (21:00 hours) as shown in red on the attached plan or along any part of such streets or roads
  - (b) The provisions of (a) above shall only apply during such times and to such extent as shall from time to time be indicated by traffic signs or otherwise upon the direction or with the permission of a Police Constable in uniform.
  - (c) None of the foregoing provisions shall apply to any vehicle being used by or on behalf of the Police, Fire Brigade or Ambulance Services.
- 2 This Order may be cited as The Parish of Eckington Temporary Street Closure Order (No 19) 2024 and shall be effective on the 6<sup>th</sup> day of December 2024.
- 3 North East Derbyshire District Council hereby directs the constables stationed at the approaches to the roads and streets the subject of this Order to take all and any steps as in their discretion are necessary to keep order and to prevent the roads or streets being obstructed including if and where necessary the total closure of the said roads and streets but subject to the provisions of 1 (c) above.

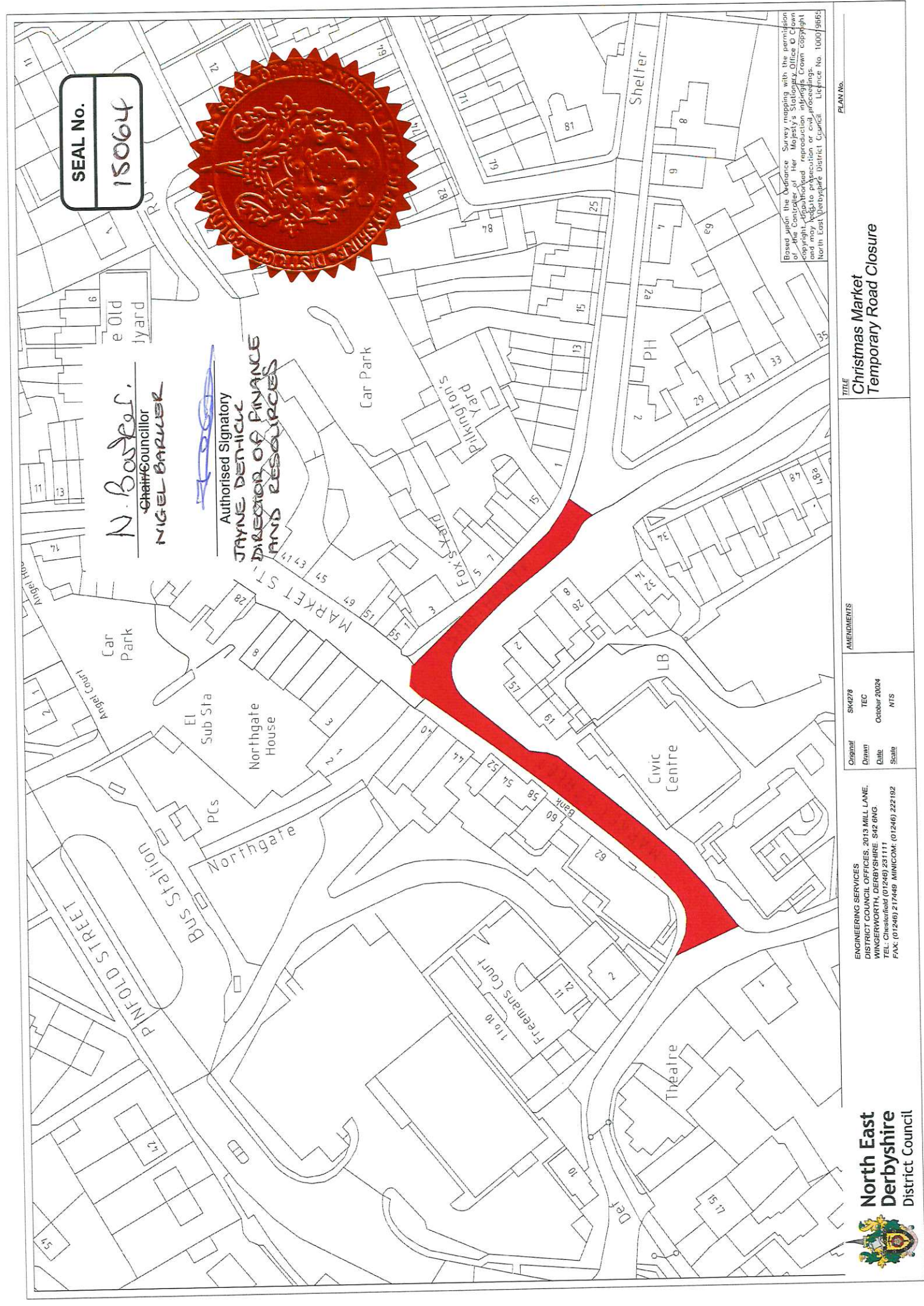
