**RESOLVED** This application is to build a house on a parking area that is used for the parking for residents of the flats inside the former Angel Hotel. When the Angel Hotel was converted into flats, application 11/00685/FL, a condition was placed on it that says: "Before the dwellings are first brought into use, the area shown on the approved plans as reserved for the parking, garaging, circulation and standing of vehicles, shall be provided in accordance with the approved details. Thereafter the area shall be used for the parking of residents and visitors' vehicles only." This condition is stated in the planning permission, which you can find appended to the document on the planning portal titled "SECTION 106 AGREEMENT", dated 5 Feb 2013. This condition is even more relevant in 2023 than when it was first agreed by the applicant in 2012.

The current application removes that existing parking provision. Not only that, but it will also make inaccessible the two parking spaces provided in front of the two houses adjacent to the intended house. So, there will be a loss of 8 or 9 parking spaces for the existing 8 dwellings, and creation of a new dwelling, leaving a total of 11 dwellings with no parking provision.

The nearby public car park is provided by NEDDC and is intended for use of visitors to the town centre shops. This small car park is already under significant pressure, and unfortunately it will be the only option left to those losing their current parking provision. This will likely result in the car park becoming time limited, leaving no parking for these residents.

Since the previous application, Eckington market has been completely revitalised, significantly worsening car parking problems on market day. The Leisure Centre and Civic Centre are now also attracting significantly higher volumes of visitors from the nearby towns, and South Sheffield, adding even more to the car parking pressure.

The displacement of residential car parking will increase pressure on already limited public car parking. This would be contrary to the aims of the Eckington Development Framework in creating a vibrant town centre.

Local Plan policy SP3 expects developments to contribute to the success of Eckington Town centre, per the Eckington Development Framework, and that success depends on visitor footfall, to allow the shopping area, including the Northgate house shops, to be successful. Available Public car parking is a necessity to support that.

The proposed development would also be contrary to the requirements of policies SS7 and SDC12 of the North East Derbyshire Local Plan and the Council's Supplementary Planning Document, Eckington Development Framework.

The applicant previously recognised this car parking need in their prior application, 19/00721/FL, and attempted to provide 11 parking spaces in nearby land, but that was rejected as being an unsuitable location for the parking due to the Eckington Development Framework SPD.

The public transport provision from Eckington continues to worsen even further between the 2020 application and 2023, with another route being reduced. Even several years ago, the Local Plan evidence base referred to how 85% of Eckington residents commute by car. Since then, that has risen as local jobs within Eckington have declined considerably. The reality is that Eckington is not a sustainable location for people to work locally or commute by public transport, and cars are essential for the large majority of residents.

In the 2020 application form, question 10, the application fails to disclose that 8 or more car parking spaces are being removed - a significant omission, especially as the spaces are provided per a previous Section 106 agreement the applicant undertook only ten years ago.

Further, the reason given for rejecting this third house in planning application 19/00721/FL, namely that it affects the ground floor flat in the Angel Hotel, still applies. Further, the reason given for rejecting this third house in planning application

12/00017/FL, namely that it affects the setting of the listed building the Angel Hotel in a Conservation Area, still applies. The reason for rejection was: "9. Having regard to all of the written representations I conclude that the development proposed would fail to enhance the character and appearance of the Eckington & Renishaw Park Conservation Area and would have an adverse effect on the overall street scene and the setting of the listed former Angel Hotel. It would be contrary to those parts of the development plan policies to which I have referred above and be unacceptable".
